Mech-Tech College, LLC notifies the community about having signed and submitted the Funding Certification and Agreement to the Secretary of Education of the United States, accepting the funds allocated under Section 314(a)(4) of the Coronavirus Response and Relief Supplemental Appropriations Act 2021 (CRRSAA) (Pub. L. 116-260), to provide emergency financial aid grants to those students showing exceptional need.

Mech-Tech College, LLC was allocated \$3,470,017 under Section 314(a)(4) of the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA) (Pub. L. 116-260). Said allocation will provide emergency financial aid grants to eligible students in accordance with the provisions established under Section 314(c)(3) of the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA) (Pub. L. 116-260). Students may use their grants to cover tuition, food, housing, health care, or child care costs.

This is Mech-Tech College's third report for the quarter ending on December 31, 2021. During said quarter, \$1,078,629 were disbursed from those funds allocated by the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA) (Pub. L. 116-260) (HEERF II).

Mech-Tech College estimates that the fund will impact 2,479 eligible students based on the criteria established under HEERF II. Students at all branch campuses in Puerto Rico, and at Mech-Tech Institute in Orlando, FL will be considered.

In this quarter ending December 31, 2021, there were 771 students who received emergency financial aid.

For the awarding of emergency grants, students at all branch campuses in Puerto Rico, and at Mech-Tech Institute in Orlando, FL who both submitted the Free Application for Federal Student Aid (FAFSA) and are Pell Grant recipients will be evaluated. The same is also true for all students who submitted their Free Application for Federal Student Aid (FAFSA) and were not eligible to receive Pell Grant disbursements.



Students will receive an e-mail informing them of their eligibility: they will also be informed about the emergency costs they may cover with the aid they are awarded, including tuition, and the amount they are being awarded. The e-mail will include a link to the consent form they need to fill out in order to receive the funds.
